

## Trading League Rules

### Online trading competition with real money

The Trading League is a real money trading competition, during which participants must demonstrate their skills in trading strategies.

Each contest will last for 1 week of the stock exchange (Mon-Fri) and the winner will be the trader who proves to be the best in the course of 2 matches, one that lasts for 4 days and also adapts to multi-day trading, the other instead, is a very intensive trading session, which lasts for 1 hour starting from the opening of the Wall Street.

A special mention will be reserved to the maker of the highest gain in absolute value (Most Money Made - MMM), which is obtained by adding up the results of the two matches, regardless of the initial capital.

The Trading League is made up of 6 contenders each time, and it consists of 4 seasonal events and ends with the Master Grand finale, to determine the podium of the Three best traders of the year.

The performances achieved by the participants are guaranteed and certified by Directa SIM.

### **Trading League Rules:**

1. Each event lasts for 1 Stock Exchange trading week (5 days - Mon-Fri)
2. consists of 2 sessions and it has 6 participants
3. 1st match from Monday at 08:00 to Thursday at 18:00 - 2nd match from Friday at 15:00 to 16:00
4. The participants are selected at the unquestionable discretion of the organization
5. The minimum capital to participate is €1000.00 (one thousand, 00 euros)
6. There is no maximum limit for the initial capital
7. No withdrawal or further deposit can be made to the account during the competition
8. Participants must carry out at least 1 trade transaction in each match, otherwise penalty of disqualification
9. The account used by the participants must be liquid (money only), at the beginning and end of the matches
10. All positions must therefore be closed no later than the end of each match
11. The Trader who will not close the positions will be considered "Not Ranked" for the purposes of the Competition
12. The ranking of each match is based on the performance obtained as a percentage of the initial capital
13. The final ranking will be determined by the sum of the points obtained in the 2 sessions
14. The Trader who will achieve the highest score will win the Trading League

### **Points assignment per each match:**

1. 1st place: points 9
2. 2nd place: points 6
3. 3rd place: points 4

4. 4th place: points 3
5. 5th place: points 2

In case of equal points after the 2 matches, the winner will be the trader who:

1. will have achieved the greatest gains in absolute value (Most Money Made) globally
2. will have performed the single operation with the greatest gain in absolute value
3. will have achieved the global performance with the least number of transactions (best average profit)
4. will have reached the final performance first
5. will have achieved the single operation with the best percentage gain
6. in case of a further tie, the placement will be considered ex-aequo

The Trading League consists of 4 seasonal rounds (Winter, Spring, Summer and Autumn) and ends with a grand finale - **the Master** - to proclaim the podium of the best 3 traders of the year:

- The winner of each Season Final will be rewarded with the title of Seasonal Champion of the Trading
- League and can boast of the prize, in addition to qualifying for the annual Grand Final: the Master.
- The winner of a seasonal round can not take part in the following seasonal rounds, being already qualified for the annual final (the Master).
- The other participants could instead be re-invited to participate.
- The 4 winners of the Seasonal Stages will have access to the final master as well as 2 Wild Card holders, selected by the organization
- The Master takes place with the same rules of the seasonal competitions.
- A special mention will always be given to the maker of the best gain in absolute value (Most Money Made - MMM), obtained by adding up the results of the two matches, independent from the initial capital

### **Markets accessible for the trading operations**

All regulated markets accessible through Directa will be available for the trading operations. During the 1st match, participants can also place multi-day orders, to be closed by the end of the match.

### **Competition Features**

Participants will be able to take advantage of all the features offered by the broker, including the use of intraday and multiday leverage. The counting of the results will be net of fees; every trader will be free to choose the commission profile he prefers among those offered by Directa. The competition will be inclusive of the capital gain, because the tax may vary according to the residence of the competitors.

## **Performance**

In order to calculate the percentage performance which determines the winners of the challenge, traders will trust in Directa's declaration which certifies and guarantees the performance.

## **Participants Selection**

The selection of the 6 participants in the seasonal competitions is by unquestionable judgment by the organization.

## **Participants' good faith**

Participants undertake to compete according to fairness, good faith and fair play. They also undertake to operate in accordance with the provisions of the supervisory bodies and the regulations laid down by the markets

## **How to follow the results - Ranking publication**

On the website: [www.trading-league.com](http://www.trading-league.com) the real-time rankings are shown in a dedicated page accessible with free registration and then by just logging in. The 2nd 2-hour trading competition will also be broadcasted in live streaming.

## **Organization of the Trading League**

The organizer of the Trading League is Carisma Srl in collaboration with Directa. The organization supervises the regularity of the championship and, for this purpose, deliberates at their own discretion any penalties or sanctions, up to the exclusion from the competition, as well as announcing the winners and the selection of the participants, including the Wild Cards. The Organizer reserves the right to bring about changes to the competition at any time.
